Job Summary

Be the key leader of the NYLT session. Working with the Youth Course Lead, the Course Director, and the Scoutmaster plan and run all staff development meetings. Lead the youth staff and patrols in daily NYLT activities. Model the linked troop model if required. Mentor the youth staff. Work with the Youth Course Lead and the other SPLs on your course to coordinate activities throughout the course.

Job Description

ROLE AND RESPONSIBILITIES

- Attend all Staff Development Trainings, should be IN PERSON (including All Hands, Staff Developments, and other trainings as required by Council.)
- Work with the Youth Course Lead to coordinate activities amongst all troops on course.
- Work with the Youth Course Lead to lead staff development meetings, troop meetings, events, traditions, and activities.
- Must attend all NYLT Mandatory Training Dates, Staff Developments, and the entire week of course.
- Chairing meetings of the Leadership Council (PLC).
- Mentor and guide the youth staff through the chain of command, during staff developments and on course. The SPL MUST develop their team during the staff development process to ensure that their team is ready to lead the best NYLT course possible.
- Delegate duties and responsibilities to other NYLT youth staff.
- Assist the Scoutmaster in staff training.
- Model core learning and leadership messages as outlined in the NYLT syllabus.
- Recruit youth staff.
- Recruit youth participants.
- Be well-versed in all core content sessions.
- Be familiar with camp emergency procedures.
- Report all issues with participants or staff to the NYLT Scoutmaster and MSR Ranch Director as necessary.
- Other duties as assigned.

CERTIFICATIONS & REQUIRED TRAINING

- CPR, AED, First Aid Certification (Not provided by the Council)
- Youth Protection (Online Prior to Camp)
- Other training as required by Council and NYLT Management

REQUIRED FOR THE JOB

- Must have staffed NYLT at least 2 times (should serve as TG, QM or Instructor, and as an ASPL at least one time)
- Must be able to read, speak, and write the English language
- Must be able to work outdoors at an elevation of 7,000+ feet above sea level in varying weather conditions
- Must complete all required State, Council, and National trainings, and paperwork on time.
- Must be able to pass a background check from the TRAILS database, CBI, and the FBI .
- Must be a current member of Scouting America
- Must be 16 years of age or older.

If you need to miss a second Staff Development meeting, you need to have a conversation with your NYLT Scoutmaster, NYLT Senior Patrol Leader, the NYLT Course Director, and your Parent(s)/Guardian(s).

If you need to miss a third Staff Development meeting, you will need to have a conversation with the Council Coordinator and your Parent(s)/Guardian(s). This conversation will likely end in you being asked to not staff NYLT for the year, as we need staff to be able to commit to the entire process of NYLT, staff development through graduation on course.
